



Red Velvet Cake Cookies

2. Mix ingredients in a bowl—combine the cake mix, eggs, and vegetable oil until well

3. **Shape the dough** into 24 balls and arrange them on an **ungreased baking sheet**.

5. **Cool** on the baking sheet for **2 to 3 minutes**, then transfer to a wire rack to cool

4. Bake for 7 to 9 minutes or until lightly browned around the edges.

For a softer texture, slightly underbake and let the cookies firm up as they cool.


