



## **Grilled Chicken Kabobs** A colorful and easy addition to your 4th of July BBQ

#### **Ingredients:**

- 4 skinless, boneless chicken breast halves cubed
- 1 large green bell pepper, cut into 2-inch pieces
- 1 onion, cut into wedges
- 1 large red bell pepper, cut into 2-inch pieces
- 1 cup barbeque sauce
- Skewers (if wooden soak in water for 15 min)

#### **Directions:**

1 - Preheat grill for high heat.

2 - Thread the chicken, green bell pepper, onion, and red bell pepper pieces onto skewers alternately.
