Should You Let Your Child Take a Car to College?

PRO: Your child will be able to come home whenever they want to. PRO: It makes it easier to have a part-time job. If your child needs to work to help pay for their tuition and other expenses and they do not have an on-campus work study job, a car can make it much easier to get to and from a job. Not having to rely on public transportation means less time commuting and more time and energy for studying.

PRO: The convenience factor. Depending on your child's campus and housing accommodations, a car may be a big help if they need to grocery shop, drive to a laundromat or travel between campuses for classes or labs.

CON: Parking problems. A key factor in making this decision is finding out what the college's parking regulations and availability are. Many schools don't allow first-year parking privileges. Even if allowed, spaces may be limited. Driving around looking for a space can be an unnecessary stress and make you late for class. Or it can be a costly proposition if your student ends up parking illegally and getting ticketed.

CON: Added responsibility, added temptation. If college is your child's first experience of truly being on their own, there's a lot of to learn about taking care of yourself and being responsible. A car adds a whole other level of work. Dealing with car maintenance, parking safely and legally, and driving without distractions may be more than your child needs. Other students may pressure your child into being the driver for shopping and entertainment, adding the potential danger of driving under the influence.

CON: The cost. With the expenses of tuition, books and living expenses can you or your child also afford the costs associated with a car, such as gas, insurance, maintenance, and repairs?

Knowing your child and gathering as much information as possible about the benefits and liabilities of having a car at the school where they are headed will help you make the best choice.



Slow Cooker Peach Crumble Make the most of peach season!

Ingredients:

- 1 tablespoon butter, softened
- 6 large ripe peaches, peeled and sliced (about 6 cups)
- 2 tablespoons light brown sugar
- 1 tablespoon lemon juice
- 1 tablespoon vanilla extract
- 2 tablespoons coconut rum, optional

....continued from page 5 **Slow Cooker Peach Crumble....**

For Topping:

1 cup all-purpose flour
 3/4 cup packed light brown sugar
 1-1/2 teaspoons baking powder
 1 teaspoon ground cinnamon
 1/2 teaspoon baking soda
 1/8 teaspoon salt
 1 cup old-fashioned oats
 6 tablespoons cold butter, cubed
 Whipped cream, optional

Directions

1. Grease a 6-qt. oval slow cooker with 1 tablespoon softened butter. Toss peaches with brown sugar, lemon juice, vanilla and, if desired, rum; spread evenly in slow cooker.
2. Whisk together first 6 topping ingredients; stir in oats. Cut in butter until crumbly; sprinkle over peaches. Cook, covered, on low until peaches are tender, 3-4 hours. If desired, serve with whipped cream.
